In view of the continuing Covid-19 pandemic and the restrictions imposed on the movement of people, the Ministry of Corporate Affairs ("MCA") vide its circular dated 5<sup>th</sup> May 2020 read with circulars dated 8<sup>th</sup> April 2020 and 13<sup>th</sup> April 2020 and SEBI vide its Circular No.SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated 12<sup>th</sup> May 2020 (collectively referred to as "Applicable Circulars") have permitted the holding of the AGM through Video Conference / Other Audio Visual Means.

**Procedure for e-voting:** Pursuant to the provisions of Section 108 of the Companies Act, 2013; Rule 20 of the Companies (Management and Administration) Rules, 2014, (including any statutory modification(s) or re-enactment thereof, for the time being in force), Regulation 44 of Listing Regulations, 2015 and Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India, your Company is pleased to provide Members with a facility to exercise their right to vote by electronic means for the business to be transacted at the AGM.

The remote e-voting period commences on Monday the 21<sup>st</sup> September 2020 (9:00 A.M. IST) and ends on Wednesday the 23<sup>rd</sup> September 2020 (5:00 P.M. IST). The facility for e-voting electronically shall also be made available at the AGM for the members who have not already cast their vote prior to the AGM by remote e-voting. The detailed procedure for e-voting is given in the Notice of the 29<sup>th</sup> AGM.

22<sup>nd</sup> September 2020 at 05:00 P.M. (IST) shall be considered and responded to, prior / until the date of the AGM by way of email.
