We are pleased to inform you that the 29th Annual General Meeting (AGM) of our company is scheduled on Thursday the 24th September 2020 at 11.30 a.m. (IST) through Video Conference (VC) / Other Audio Visual Means (OAVM) to transact the business as set out in the notice dated 29th June 2020 which is enclosed herewith.

In view of the continuing Covid-19 pandemic and the restrictions imposed on the movement of people, the Ministry of Corporate Affairs ("MCA") vide its circular dated 5th May 2020 read with circulars dated 8th April 2020 and 13th April 2020 and SEBI vide its Circular No.SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated 12th May 2020 (collectively referred to as "Applicable Circulars") have permitted the holding of the AGM through Video Conference / Other Audio Visual Means.

Procedure for e-voting: Pursuant to the provisions of Section 108 of the Companies Act, 2013; Rule 20 of the Companies (Management and Administration) Rules, 2014, (including any statutory modification(s) or re-enactment thereof, for the time being in force), Regulation 44 of Listing Regulations, 2015 and Secretarial Standard on General Meetings (SS-2) issued by the Institute of Company Secretaries of India, your Company is pleased to provide Members with a facility to exercise their right to vote by electronic means for the business to be transacted at the AGM.

The remote e-voting period commences on Monday the 21st September 2020 (9:00 A.M. IST) and ends on Wednesday the 23rd September 2020 (5:00 P.M. IST). The facility for e-voting electronically shall also be made available at the AGM for the members who have not already cast their vote prior to the AGM by remote e-voting. The detailed procedure for e-voting is given in the Notice of the 29th AGM.

22nd September 2020 at 05:00 P.M. (IST) shall be considered and responded to, prior / until the date of the AGM by way of email.

Members who would like to register themselves as a speaker shall send an email with the details of name, DEMAT account number/folio number, email id, mobile number to cs@iprings.com and only email request alone shall be entertained to enrol as speaker as the portal should be used only to raise questions to be replied by the Company.

Members who hold shares of the Company as on 31st August 2020 being the cut-off date for this purpose and have registered themselves as a speaker will be allowed to express their views / ask questions during the AGM and they may have to allow camera access during the AGM. The Company reserves the right to restrict the number of speakers depending on the availability of time for the AGM. The shareholders who have registered themselves as a speaker shareholder will only be allowed to express their views/ask questions during the meeting.
